DIRECTIONS Please mail or hand-deliver the signed forms and documentation to the address above. Our typical turnaround for processing is 3-5 days. We will mail the Letters of Administration directly to the Personal Representative. If you prefer to pick them up, please leave a note with the paperwork and we will call when they are ready. If you prefer to schedule an appointment, please call the office directly.

A Notice to Creditors will run in the Aegis. We take care of sending the notice to them and they will bill you directly. Please note that this process simply establishes the estate. There will be additional filing requirements. More information can be found on our website under the Publications tab in the "Administering Estates in Maryland" booklet.
